I confirm that the information I have provided is true and complete and make the data available to TUM for internal processing. The required supporting documents are attached. I am aware that false statements may result in the termination of enrollment.

The personal data collected here will be processed at TUM for the following purpose: Application for a place as an auditor at the Technical University of Munich. The data collected will be kept for one year, ten years in the case of admission or rejection, and thirty years in the case of enrollment.

My personal data collected as part of the aforementioned purposes will be processed in compliance with the European Data Protection Regulation (DSGVO), the Bavarian Data Protection Act (BayDSG) and the Bavarian Higher Education Innovation Act (BayHIG). In particular, Art. 6(1) e) of the DSGVO, in connection with Art. 87(2) and (3) BayHIG, apply here.

According to legal requirements, there is a right to information, as well as to correction or deletion or to restriction of processing or a right to object to processing, as well as the right to data transferability. There is also a right of appeal to the Bavarian State Commissioner for Data Protection.

I further declare that as an auditor of the Technical University of Munich I will inform myself about the academic regulations and deadlines for the courses I attend, as well as deadlines for re-enrollment as an auditor.
